## Bonus Dividends & Loan Interest Rebates-

We'd like to share the success with you, the owners of the credit union, by giving back a Bonus Dividend and Loan Interest Rebate.\* Including quarterly dividends, Bonus Dividends and Loan Interest Rebates, we are returning over \$250,000 to our members for 2023...a great example of the CREDIT UNION DIFFERENCE! We value your membership and look forward to serving you in 2024!

Bonus Dividend- We added an additional HALF of the dividends that you were paid in 2023 to your account on or around 12/18/2023. All Bonus Dividends were paid into your primary (01) account.

<u>Loan Interest Rebate</u>-Auto loans and share secured loans earned a rebate of \$80 and Signature Loans earned \$40, deposited to your primary share account on or around 12/18/2023.

\*Bonus Dividend is an additional 50% of your YTD taxable dividend as of 10/1/2023 and is also taxable. Maximum loan interest rebate per member is \$200. Loan interest rebates apply if you had a loan as of 9/30/2023 and were not more than 60 days delinquent currently or at any month-end in 2023.
